#### GOSHEN BOARD OF FINANCE

### REGULAR MEETING

## WEDNESDAY, APRIL 28, 2021

This meeting was held via Zoom.us and is available as a recording.

CALL TO ORDER: Allan Walker called the meeting to order at 7:30 p.m.

ATTENDANCE: Allan Walker, Ned Bixler, Russell Hurley, Scott Tillmann, William Lane and alternate, Patrick Reilly.

ABSENT: Jim Korner

SEATING OF AN ALTERNATE: Ned Bixler made a motion seconded by Scott Tillmann, to seat Patrick Reilly as a regular member for this meeting. The motion passed.

APPROVAL OF MINUTES: Ned Bixler made a motion seconded by Scott Tillmann to accept the minutes of the March 24, 2021 meeting as presented. The motion passed.

FINANCIAL REPORTS: A motion was made by Bill Lane and seconded by Russel Hurley to accept Debbie Franklin's reports. The motion passed.

TAX COLLECTOR'S REPORT: The Tax Collector's report was received and reviewed by the Board of Finance. Russell Hurley made a motion to allow the Tax Collector to put the listed accounts on the Suspense List. The motion was seconded by Patrick Reilly and passed.

### **CONSIDERATION OF BUDGETS:**

<u>PUBLIC WORKS – DEPT. 02:</u> Current Budget 2020-2021 \$1,102,537.00, Proposed Budget 2021-2022 \$1,010,800.00. To help avoid a 2.4 mil rate increase, \$100,000 was removed from the Chip Seal line item and \$150,000 from Major Roads Project. These funds will be replaced with Town Aid Road funds.

<u>RECREATION – DEPT 22:</u> Current Budget 2020-2021 \$192,540.00, Proposed Budget 2021-2022 \$186,934.00. We have hired a new Recreation Dept. Director.

<u>TOWN OFFICE BUILDING – DEPT 01:</u> Current Budget 2020-2021 \$70,802.00, Proposed Budget 2021-2022 \$69,581.00

<u>CONTINGENCY- DEPT 59:</u> Current Budget 2020-2021 \$40,000.00, Proposed Budget 2021-2022 \$40,000

<u>NEWSLETTER – DEPT 55:</u> Current Budget 2020-2021 \$21,050.00, Proposed Budget 2021-2022 \$22,170.00. Approximately \$3,800 in revenue from ads is anticipated.

<u>WASTE REMOVAL – DEPT 03:</u> Current Budget 2020-2021 \$215,646.00, Proposed Budget 2021-2022 \$248,161.00. The largest part of the increase is due to an increased cost of the contract with MIRA. The recycling contract also had a large increase.

<u>INSURANCE</u> Current Budget 2020-2021 \$101,767.00, Proposed Budget 2021-2022 \$111,389.00. Most of the increase is due to a 5.8% increase in the Property & Casualty insurance for the Fire Company

<u>EMPLOYEE BENEFITS- DEPT 71:</u> Current Budget 2020-2021 \$420,042.00, Proposed Budget 2021-2022 \$383,644.00

# CAPITAL REQUESTS:

Animal Control: \$74,000 for Goshen's 6.7%,

Recreation: \$26,5000 for pavilion and sheds

Public Works: \$345,001.00 with \$150,000.00 from Town Aid Road

Selectman: \$21,000.00 Patrick Reilly made a motion seconded by Bill Lane to approve a 2.5% increase for elected officials, election workers and contract workers. The motion passed.

Scott Tillmann made a motion seconded by Patrick Reilly to include all contractors in the 2.5% increase. The motion passed.

PUBLIC COMMENT: Chris Sanders requested a chance to speak for the Lake Weeds Committee. He gave a comprehensive report on the progress and future plans to control the weeds in Tyler Lake, West Side Pond, and Dog Pond. He reported that they had received an \$11,000 grant from DEEP to help with the cost of the West Side Pond project. Mr. Sanders urges the town's continued financial support at the \$15,000 per lake level.

ADJOURN: A motion was made by Scott Tillmann and seconded by Bill Lane to adjourn the meeting. The motion carried. The meeting was adjourned at 9:00pm.
