- **1.** Call to order: Todd M. Carusillo called the meeting to order at 5:01 p.m.
- Approval of the minutes of the meeting of January 2, 2024. In a motion made by Scott Olson, seconded by Todd M. Carusillo, it was voted to approve the minutes of January 2, 2024 as submitted. Motion carried.

7. Correspondence: Todd stated Michael Edison, President, representing the Woodridge Lake Property Association, and with the Town of Goshen had an informal agreement regarding work done by Woodridge Lake Association and work done by Town of Goshen (Public Works) i.e. sediment work, etc. Goshen's Board of Finance allocates \$20K; Woodridge Lake Association allocates \$20K. Scott Olson explained that there has been no formal agreement in writing. Todd stated the hand-shake agreement is that Woodridge Lake Association and the Town of Goshen would split the cost of materials. Ed Dutka, Property Manager for the Woodridge Lake Property Association, did not have the transactions formally recorded. Nothing criminal has ever taken place, but this agreement needs to be done differently, needs systematic method to verify the amount of the check(s). This activity merely needs a "paper trial" for accuracy. Entering into a written agreement will provide any and all verifications for *both* parties. Selectman Kinsella felt that Bob Valentine (former First Selectman) should be involved in this transaction as he represented the Town at the time this agreement was initiated. The Board is in agreement moving forward that a systematic method needs to be initiated, written invoices, payment dates, etc.
