With reference to the Animal Control Facility consortium with Goshen, Litchfield and Torrington, Litchfield has advised that they are no longer interested in funding a new building in Torrington. The next step is for Goshen to meet with Torrington to work out an arrangement that excludes Litchfield, but retains Goshen's 6.7% portion of the plan.

The Town of Goshen is working with Principal of Goshen Center School, Tracy Keilty and Steve Cahill, School Resource Officer, to create protocol for building lock-down and fire drills. In that the two buildings are connected, the alarm systems must be coordinated to facilitate for emergencies and possible threats.
