1 Robert P. Valentine called the meeting to order at 5:05 p.m.
In a motion made by Dexter S. Kinsella, seconded by Robert P. Valentine, it was voted to add to the agenda, under item 9.New Business, 9a. Library Aide. Voted unanimous.

Item 9a. Library Aide was taken up at this time.
Ms. Lynn Steinmayer reported that she has compiled a short list of candidates to fill the position of part-time Library Aide. These candidates have previous experience, good references and appear to be qualified for this position. In a motion made by Dexter S. Kinsella, seconded by Robert P. Valentine, it was voted to allow Ms. Steinmayer the latitude to hire a Library Aide accordingly. Voted unanimously.

## 4. Approval of Payroll and Warrant of April 18, 2019:

## 6. First Selectman's Report:

Bob Valentine and Virginia Perry have dedicated the majority of their hours this past week working on finalizing the town budget(s). Consideration has been given to every item from all departments. Their work has been made more difficult this year due to the uncertainty of what may or may not come from the State Legislature as it pertains to state grants to municipalities.

Bob attended a meeting in Torrington last Thursday regarding the new Regional Animal Control Facility. The final building plans are nearing completion. Goshen's share of the cost of this facility is $\$ 60,000$.

Bob attended the meeting of the Northwest Council of Governments (NWCOG) last Friday, held at the former UCONN campus in Torrington. Governor Ned Lamont was the invited guest speaker. He gave opinions on how to bring back a good working budget for Connecticut and showed interest in the opinions of the audience. Bob felt this was a refreshing posture from a sitting Governor to

garner feedback from municipal leaders. He learned that Teacher Retirement System bill did not get out "committee", but cautioned that this does not mean this bill is dead. The Governor still would like the municipalities to pay $25 \%$ of the ongoing costs

Bob reported that CCM (Connecticut Council of Municipalities) and COST (Council of Small Towns) held a joint meeting to create a list of state budget priorities for towns in Connecticut. The Connecticut Education Association (CEA) has shown an interest in what these municipal councils' issues are regarding the Teacher Retirement System.

Bob advised that Senator Martin Looney is still pursuing the $\$ 50 \mathrm{~K}$ homestead exemption and 1 mill State tax which would be added on to every municipality's mill rate. Senator Looney's elimination of the town "car tax" and moving it onto the State vehicle tax plan is still being pursued. This action will result in a 4.2 mill rate increase to Goshen.

Recognition was given to the passing of Ernest (Ernie) Barker of Goshen. Mr. Barker's service to Goshen's Library and other organizations will certainly be missed.
