**1. Call to order:** Robert P. Valentine called the meeting to order at 5:02p.m.

# 2. Approval of the minutes of the meeting of July 20, 2021:

In a **motion** made by Dexter S. Kinsella, seconded by Mark S. Harris, it was **voted** to approve the minutes of July 20, 2021 as submitted. Voted unanimous.

**3.** Matters Arising Out of the Minutes: Both Bob Valentine and Selectman Kinsella, were unable to attend the seminar on the new law regarding the usage of marijuana/cannabis in Connecticut. There are other seminars on this subject they are planning to attend.

## 4. Approval of the Payroll and Warrant – July 29, 2021

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to approve the total warrant and payroll of July 29, 2021 in the amount of \$299,031.26. Included in this warrant were the payroll in the amount of \$33,333.31, and the warrant in the amount of \$265,697,95. Voted unanimous. Invoices highlighted: Connecticare (employee health insurance): \$16,335.25; New England Asphalt (chip seal) \$201,921.66; Sepples Tree Service: (School Hill Rd.) \$10,500.

**Public Comment:** Cynthia Barrett had several comments and suggestions regarding hybrid meetings and how they could posted on the town website going forward. She also suggested a *how to use zoom meetings* should be posted, for those who are not familiar with zoom meetings. The original instructions to get into hybrid meetings were available to the public back when the COVID-19 pandemic began, those will be reposted to the town website.

# 6. First Selectman's Report:

With reference to the legalization of marijuana in Connecticut and potential issues that could arise with random drug testing of public works employees municipalities despite the **state** of Connecticut having legalized the use of marijuana, CDL drivers' licenses are a **federal** license, and therefore are *not affected* by the new **state** cannabis law. Bob stated cannabis can be regulated by town/municipal ordinance. For example, alcohol is not allowed at Camp Coch, should cannabis also not be allowed. Towns can prohibit its use on town property by ordinance if they choose.
