1. Call to order: Robert P. Valentine called the meeting to order at 5:01p.m.

2. Approval of the minutes of the meeting of September 21, 2021:

In a **motion** made by Dexter S. Kinsella, seconded by Mark S. Harris, it was **voted** to approve the minutes of September 21, 2021 as submitted. Voted unanimous.

3. Matters Arising Out of the Minutes: None

4. Approval of the Payroll and Warrant - September 30, 2021

Regarding the Corona Virus, Litchfield County continues to be doing well. Charlotte Hungerford Hospital has no COVID cases.

The position of Executive Director for the Litchfield Chore Service, Inc. has been posted on the Goshen Website, along with the job description and job application.

Bob reported that last Wednesday he, representatives from the DEEP along with Tim Abbott HVA and representatives from the U.S. Fish and Wildlife Service met at the State's new purchase of 620 acres on Beach Hill. The purpose of the meeting was to document the importance of the property and the fact that Fed funds were used to purchase it.
