4. Approval of the Payroll and Warrant –October 07, 2021

6. First Selectman's Report:

Regarding the Coronavirus, Litchfield County continues to be doing well with only 8 hospitalizations.

Mr. Andy Merola is the energy consultant for CCM (**C**onnecticut **C**ouncil of **M**unicipalities). He provides members with market opportunities with *favorable* **energy** pricing. As such, current market indicators favor re-entering the market *now* to capture future savings. Goshen's current supply agreement with CCM ends December 2022. Mr. Merola suggests that re-entering the energy market now makes sense. Bob has thus sent in the paperwork for the energy participation program for electricity. Resulting/favorable return information will determine Goshen's interest in continuing this program.

Bob reported that the nearly completed tennis courts (located adjacent to the Goshen Center School) are nearly complete- however, due to material shortage, the fences will be delayed and the finishing coating of paint on the surface of the area will also be delayed. The Goshen Center School has taken over the responsibility for this project.

8b. Affordable Housing Plan (Draft):

Having reviewed the "draft" of the Housing Plan 2022-2027, the BOS discussed several points (page 10) as it pertained to Summary of Housing Data Analysis for Goshen, compared to neighboring towns, i.e., Cornwall, Norfolk, Litchfield, Morris and Warren. What are the criteria? What is the diversity of Goshen? Additionally, (page 14) resources for those who are at risk of becoming homeless were also discussed. It was emphasized that it is the responsibility of the Planning & Zoning Commission to implement the regulations in moving this plan forward. If the Planning & Zoning Commission does create changes in zoning regulation for items in the plan, a public hearing would have to be held before those changes could become part of the zoning regulations.

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to adopt the Housing Plan 2022-2027. Voted unanimous.
