1. Call to order: Todd M. Carusillo called the meeting to order at 5:01 p.m.

2. Approval of the minutes of the meeting of March 29, 2022:

In a **motion** made by Mark S. Harris, seconded by Todd M. Carusillo, it was **voted** to approve the minutes of March 2, 2022 as submitted. Motion passed with Dexter S. Kinsella abstaining.

4. Approval of the Payroll and Warrant – April 7, 2022:

5. First Selectman's Report:

Last week COVID-19 cases in Litchfield County were down to 3, however, the number is back down to 0. Good news!

In his continuing efforts concerning Animal Control services for Goshen, Todd had conversations with First Selectmen, Denise Rapp (Litchfield) and Mike Criss (Harwinton) regarding an Animal Control Facility. Mr. Criss needed to give the cost of the maintenance of the truck and percentage of pay for the Animal Control person. Todd had a discussion with Jack Malahan, who does animal control in Cornwall. Mr. Malahan will fill out an application for hire as "assistant Animal Control" person to fill in when the others are unable to respond to a call from Goshen.
