- 1. Call to order: Todd M. Carusillo called the meeting to order at 5:00 p.m.
- **2. Approval of the minutes of the meeting of October 4, 2022,** In a **motion** made by Dexter S. Kinsella,, seconded by Mark S. Harris, *it was voted to approve the minutes of September October 4, 2022 as submitted.* Voted unanimous.
- **3.** Matters Arising Out of the October **4, 2022** meeting: **9b.** Selectmen gave approval of the sale of a used tractor owned by Town of Goshen. The amount given at the <u>recording of the minutes</u> was \$3,500 for the 1991 Heston 45-66 4x4 loader tractor. The amount of money actually received via the <u>final</u> sale for this Heston tractor was \$2,500.

Included in this warrant: Friends of West Side Pond: \$25,000; GFC Ambulance/Fire Truck: \$327,350.75; Tyler Lake Protective Assoc. - \$25,000; Yucatech- \$3,805.92.

A purchase order for a box grader – \$1,099.00 has been submitted to conduct repairs/regrading for the track at Camp Coch. A roller may be rented also.

The subject Tax Collector's Report was reviewed by the Selectmen. The Collection Rate- collected less refunds vs. total budgeted is 59.41%, which is very good.
