# **TOWN OF GOSHEN BOARD OF SELECTMEN REGULAR MEETING MINUTES**

1 Robert P. Valentine called the meeting to order at 5:03 p.m.

# 2. Approve the minutes of the July 02, 2019 regular meeting:

In a motion made by Dexter S. Kinsella, seconded by Steven M. Romano, it was voted to approve the minutes of the July 02, 2019, meeting as submitted. Voted unanimous.

# 4. Approval of Payroll and Warrant of July 11, 2019:

In a motion made by Steven M. Romano, seconded by Dexter S. Kinsella, it was voted to approve the total warrant and payroll for July 11, 2019 in the amount of \$65,261.88. Included in this warrant were the payroll in the amount of \$28,738.20 and warrant in the amount of \$36,523.68 Voted unanimous. Included in this warrant was Northeast Crack Fill - \$12,389.50; Rivco (oil tank installation) \$8,800.; United Concrete \$4,684.

# 6. First Selectman's Report:

Bob reported that he used Goshen's public notification system and radio WZBG, to notify the public that the center circle will be under construction from all four directions (Tuesday, July 9, 2019). As such, he advised local residents and travelers to use alternate routes, to avoid traffic backups.

Bob will attend a "pre-bid" meeting in Torrington tomorrow July 10th regarding the Litchfield Hills Regional Animal Facility (Goshen, Litchfield and Torrington). The bid opening date is July 24, 2019.

Bob reported that applications are lagging concerning the Caroline T. Brooks Fund. Many residents believe that these funds are solely for assistance with dental work, while in fact other medical needs for assistance can be applied for i.e., eye/vision, hearing, and etc. He asked the Selectmen to re-double efforts to get the word out that these funds are available. Bob has also reached out to Goshen Center School personnel to help in this endeavor. An informational article will appear in the next issue of *Town Topics*.

The old underground fuel tank located at the Goshen Fire Company has been removed. The new above ground tank has been installed. Tests results from the soil adjacent to the tank showed there to be no contamination, the soil is clean. There are no longer any underground fuel tanks for the town of Goshen.

Soil testing/samples in the area where the solar array installation will take place adjacent to the Town Hall have been taken (Region 6 installation). Bob will advise of the following steps to be taken.

The question of the security of the town computer system was discussed in light of other municipalities having ransomware infect their systems. Bob stated that regular review of security is done by the town IT contractor as well as review of State of Connecticut Homeland Security bulletins on the subject. In addition, off site backups are performed nightly. Bob will speak to the towns IT contractor and see if additional measures are available, to protect the town system.
