3. Matters Arising out of the minutes: Bob Valentine has researched Food and Nutrition Services Farmers' Market Nutrition Program (FMNP) offered by the Department of Agriculture. The program offers farm fresh produce from local farmers markets to seniors within income limits. It appears this program is more suited to larger municipalities in that the paperwork required, i.e., rules/regulations, auditing are overwhelming when compared to the small number of seniors from Goshen who would qualify for same. Therefore, in conversations with Debbie DiPetro, Goshen Community Care and Hospice and Agent for the Elderly, seniors can take advantage of the Goshen Community Garden by attending the Senior social on Tuesdays at the Church of Christ Congregation or contacting Debbie DiPetro .

All activities that took place at the Goshen Agricultural Fair this past weekend went very well; all emergency plans were in place and there were no incidents to report.

The compensation for Goshen's Fire Marshal for duty at special events has been resolved in that it was agreed to \$36.00/hr., calculated from his time card to be submitted accordingly.
