1 Call to order: Robert P. Valentine called the meeting to order at 5:06 p.m.

2. Approval the minutes of the meeting of August 18, 2020:

In a **motion** made by Mark S. Harris, seconded by Robert P. Valentine, it was **voted** to approve the minutes of August 18, 2020. Voted unanimous.

4. Approval of the Payroll and Warrant – August 27, 2020:

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to approve the total warrant and payroll of August 27, 2020 in the amount of \$1,469,616.36. Included in this warrant were the payroll in the amount of \$23,572.21 and the warrant in the amount of \$1,446,044.15. Voted unanimous. Included in the warrant were: John Hancock (pensions) \$5,417.28; RSD # assessment \$1,431,473.00.

5. Public Comment:

Courtney Fern, expressed concern for an elephant at RW Commerford.

Audrey Blondin, expressed her thanks for a "job well done" during and after Isasis storm to maintain assistance/help to the Goshen residents. To this end, she asked how residents can get on a list to be contacted during emergencies.

Bob directed her to the town web site to sign up for notifications.

Ms. Blondin felt the "Ballot Boxes" for the Absentee Votes cast in the recent primary worked very well.

Ms. Blondin stated that she was relieved to know that the Goshen Stampede will not take place this year at the Goshen Fairgrounds. Bob stated that the Goshen Agricultural Society Board of Directors voted to reject events involving large numbers of attendees at this point in time.

6. First Selectman's Report:

Bob Valentine reported that in an effort to update the town's purchase policy a committee consisting Don Sage, Fire Commissioner, Ned Bixler of the Board of Finance and himself are asking boards, commissions and department for their input for improvements. They will have until the end of the month to submit comments. Selectman Kinsella felt it important to maintain the intent of the policy, which is to arrive at the best value.

Currently the Governor's Executive Orders (ref. COVID-19) expire on Wednesday, September 9th. However, it appears that perhaps these orders may be extended.

Bob continues to work via his position on ACIR to suggest that changes should be made to Statutes that would allow boards and commission meetings virtually and in person in the future, as well as town meetings.

The Tyler Ridge Subdivision (created in 2008) has now completed the final monumenting of the corners and mapping. The Planning & Zoning Commission will be considering recommending the town take the subdivision road as a town road at their meeting tonight.

Bob brought forward a recommendation that capital appropriations for the current year be considered by the selectmen for recommendation to the board of finance given most were tabled when the budget was adopted.
