**1 Call to order:** Robert P. Valentine called the meeting to order at 5:00 p.m. At this time, Bob Valentine explained the newly purchase electronics equipment for facilitating hybrid meetings which includes a 75" TV screen, speakers, microphones and camera.

## 2. Approval the minutes of the meeting of November 3, 2020:

In a **motion** made by Dexter S. Kinsella, seconded by Mark S. Harris, it was **voted** to approve the minutes of November 3, 2020 as corrected. Selectman Harris merely "received" the public comments following his stating the position of the BOS to "Hawkers and Peddlers" law for the town of Goshen. His comments were not to be construed as an apology. Voted unanimous.

#### 4. Approval of the Payroll and Warrant – November 12, 2020:

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to approve the total warrant and payroll of November 12, 2020, in the amount of \$44,025.67. Included in this warrant were the payroll in the amount of \$29,864.76 and the warrant in the amount of \$14,160.91. Voted unanimous. Included in the warrant were: Eversource (street lights) \$1,030.39; Trinity Health (medic) \$2,240.00.

**5. Public Comment:** Cindy Barrett stated the Hybrid meeting set up is wonderful. Emily Olson would like copies of the Rules of the Hybrid meeting to publish.

# 6. First Selectman's Report:

Bob Valentine reported that he has been working with Ted Orr from *Yucatech* to setup the new system which will facilitate a hybrid meeting which includes in person and electronic attendance. This meeting tonight is being conducted in HYBRID form to demonstrate the operation and feasibility of conducting such meetings. These types of meetings are now allowed by Executive Orders of Gov. Lamont during this pandemic. Using Zoom meetings a

hybrid meeting will allow individuals to log into a meeting and also vote on meeting agenda items. (A sample question was launched to those in attendance at this BOS meeting and the process went accurately and smoothly.) *An important component of Zoom meeting voting is it can be done anonymous.* For the upcoming Annual and Special Town meeting on the Monday, November 16th, only registered voters or "Electors" will be able to attend the meeting by Zoom computer log in due to the fact that everyone logged in will be able to vote electronically. Those wishing to attend remotely but not vote will be able to phone into the meeting and hear the proceedings. The meeting will also be open to the public for in person attendance following required protocol for social distancing, wearing of masks, sign-in and temperature check. The meeting will be held in **the Goshen Center School Gymnasium** at 8:00 pm

The Goshen Library has been returned to full, normal staff this week. The *Shared Work Unemployment Program* conducted during the pandemic has been suspended.

The established protocol for COVID 19 extends to the Goshen Fire Company and Goshen's EMS personnel and as such are covered under the town's insurance policy for workers' comp if they contract or are suspected of contracting COVI-19. This comes under Governor Lamont's Executive Order 7-J J J.

The **Annual Report for the Town of Goshen** has returned from the printer. Copies are available at Town Hall and the Goshen Town Website.

Bob reported his attendance at the initial meeting of the working group on collaboration between Region 6 School District and the Litchfield School District. Bob emphasized the outstanding work done by Superintendent Christopher Leone in creating the current cooperative program. The Central Offices of both districts have been combined to avoid duplication of efforts, the Business Offices have been integrated and shared bus services will soon be contracted. To be discussed by the working group are the possibility of further cooperative efforts including regionalizing parts of both school districts. Fair and equal representation of each town will be a priority. Some potential initiatives will require legislative action particularly equal representation of each town.
