1. Call to order: Robert P. Valentine called the meeting to order at 5:05 p.m.

2. Approval of the minutes of the meeting of January 19, 2021:

In a **motion** made by Dexter S. Kinsella, seconded by Mark S. Harris, it was **voted** to approve the minutes of January 19, 2021 as amended. (Tyler Lake Heights representative *will meet* with representatives.) Voted unanimous.

3. Matters Arising Out of the Minutes: None

4. Approval of the Payroll and Warrant – January 28, 2021

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to approve the total warrant and payroll of January 28, 2021 in the amount of \$33,685.52. Included in this warrant were the payroll in the amount of \$26,055.64 and the warrant in the amount of \$7,619.88. Voted unanimous.

5. Public Comment: Cindy Barrett asked about the tree stumps on Beach St., residue from the tree that was cut down. It was found that debris belongs to a homeowner on Beach St. rather than the town of Goshen.

6. First Selectman's Report:

From last week, there are 3 additional COVID -19 cases in Goshen. In Litchfield County hospitalizations increased to 20 cases.

Torrington Area Health district has reserved 5 doses of vaccine for a clinic on Saturday the 30th for town of Goshen employees over 75ys old. Because all of the town employees over 75 have already scheduled vaccine appointments we are able offer those slots to Goshen residents. The registrar of voters created a list of voters over 75, using the list, Lucille Paige, First Selectman's Aide and Erin Reilly, Agent for the Elderly and Community Care and Hospice have been

contacting residents to find individuals who have not scheduled or received a vaccination yet. After the slots are filled they will continue help those who are still in need of the vaccine, by helping them register.

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to appoint aforementioned individuals to formalize the *Affordable Housing Plan Committee*. Voted unanimous.

The Board of Finance will hold their monthly meeting on Wednesday, January 27, 2021. The Board will be discussing capital appropriations for this fiscal year. Earlier in the year the board decided to wait to make most appropriations to capital due to the potential effect COVID-19 might have on tax collections. The Board of Selectmen will again ask to prioritize the needs of the Public Works Department and the Fire Company.

Bob has created an updated spread sheet showing the effect additional capital appropriations have on the un-assigned fund balance. He stated that Goshen's mill rate will need to increase to accommodate the capital request and the increases in the Region 6 assessment.

Also of importance, but somewhat smaller expense that cannot be overlooked, is the automatic door opener at the front entrance to Town Hall. This is the third time it has had to be repaired. This automatic door opener is mandated to aide handicapped people to enter safely. Cost of a new unit is between \$6K to \$8k.

10. Any Other Business: Selectman Dexter S. Kinsella reported that efforts have been made by volunteers to keep the skating rink clear for skating. Dexter is thinking about ways the rink could be flooded to improve the surface.
