- **1. Call to order:** Todd M. Carusillo called the meeting to order at 5:00 p.m.
- **2. Approval of the minutes of the meeting of November 21, 2023:** In a **motion** made by Scott Olson, seconded by Dexter S. Kinsella, it was **voted** to approve the minutes of November 21, 2023 with descriptions. Voted unanimous.
