**1 Call to order:** Robert P. Valentine called the meeting to order at 5:01 p.m.

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to add to the agenda item 2a. Approve the minutes of the emergency meeting of March 14, 2020; Item 8c Mowing Bids recommendation; item 9b. Tax Collector's Report – February 29, 2020. Voted unanimous.

## 2. Approve the minutes of the regular meeting of March 10, 2020:

In a **motion** made by Dexter S. Kinsella, seconded by Mark S. Harris, it was **voted** to approve the regular minutes of March 10, 2020 as submitted. Voted unanimous.

## 4. Approval of the Payroll and Warrant -March 19, 2020:

In a motion made by Mark S. Harris, seconded by Dexter S. Kinsella, it was voted to approve the total warrant and payroll of March 19, 2020 in the amount of \$64,882.94. Included in this warrant were the payroll in the amount of \$11,121.49 and the warrant in the amount of \$53,761.45. Voted unanimous. Included were payments for: John Hancock (Employees Insurance) \$4,332.29; MIRA (Tipping Fees trash) \$15,789.09; Stirling Health Insurance (Employees health insurance) \$17,469.20.

**5. Public Comment:** Regarding public gathering limits due to the coronavirus, Sean O'Neal inquired about the Goshen Stampede Special Events application. Bob Valentine stated that the application information was not complete until earlier in the day and that a legal notice will need to be run before the application can be taken up by the Board of Selectmen. The legal notice will be run this week and the application will be on the agenda for next Tuesday's Selectmen's meeting.

### 6. First Selectman's Report:

Bob Valentine emphasized that information concerning the coronavirus emergency planning is "fluid" — at this time. As of today, 40 residents in Connecticut have been reported as having been tested positive for the disease. Bob reported that this past weekend was spent communicating with: Betsy Gara, Executive Director of COST (Connecticut Council of Small Towns), and Joe Delong Executive Director CCM (Connecticut Council of Municipalities) concerning the *Governor's Executive Orders* addressing issues concerning COVID-19. Bob is purchasing online services and conference call services for boards and commissions to use for their meetings. Board of Selectmen meetings as well as all other board and commission meetings will be conducted electronically for the foreseeable future.

Bob also purchased 3 laptops which are being setup so employees can work from home through the towns private network. The Goshen Library is closed until the end of the month. Two Library Aides will be available during regular hours if residents have questions on how to download books from home. **TOWN HALL IS OPEN FOR NOW.** Residents are urged to use the various online capabilities the town has or call, rather than a personal visit to Town Hall. Taxes can be mailed and the post mark will be used for when they are received. Public Works Department will <u>not</u> be open to the public. Bob emphasized that he has been be in contact with the Governor's Office; Torrington Area Health Department; Fire Chief, Barry Hall; Jim O'Leary, Emergency Management Director. Bob complimented Richard Reis, President of the Woodridge Lake Property Owners Association, for his prompt action in closing the WL Club House. Doing so will help with slowing the spread of COVID-19.

Selectman Kinsella asked about employees who may need to stay home or be quarantined, if they will be paid. Bob said that they would and it is anticipated that Federal disaster funds would be available to offset those expenses. Kinsella stated that Goshen has always had a strong sense of community, neighbors checking for the needs of their neighbors and that this attitude will get all of us through this.

In a **motion** made by Mark S. Harris, seconded by Dexter S. Kinsella, it was **voted** to enter into a contract for the Municipal Lawn Mowing & Brush Hogging with Hawley, LLC of Litchfield, CT. Voted unanimous.
