How Much Does Camp Cost?

2020 Camp Personnel Salary Proposal \$51,449.00; 2020 Camp Personnel Supplies: \$1,000.00; Camp Supplies: \$6,820.00; Trips: \$12,000.00 – **Total \$71,269.00**

Camp Fees due to Minimum Wage Increases:

Director Colleen Kinkade distributed a breakout sheet illustrating the increased fees to the Camp Counselors (via newly passed minimum wage State law). The current fees for this summer (2020) session will **total \$68,250.00.** Ms. Kinkade also provided a spread sheet for staff, waterfront positions, and CIT's – **Total CIT increases from 2019 to 2024: \$15,240.** Discussions followed on the financial impact to the Camp program.

Some suggestions that may help defray the impact of the cost increases:

- Leader in Training title
- Camp run from 9:00 a.m. to 4:00 p.m. (currently from 9:00 a.m. to 3:00 p.m.)
- Teen Adventure Camp in conjunction with Woodridge Lake Camp program
- Early Bird registration discount for 2021 Camp season
- Operate Concession stand at Camp; Gatorade, chips, healthy snacks.

Follow Up from 1/13/2020 meeting: Expanding Litchfield Park & Recreation Commission's Summer Day Camp program by combining with Camp Coch Summer Program Day Camp. Talks are still taking place. Litchfield is pondering the pros and cons of reducing their summer program. Further discussions will take place before a final decision will be made.

In a **motion** made by Don Patterson, seconded by Patrick Lucas, it was **voted** that additional fees at Camp Coch fees **will not** be increased for the 2020 season at Camp Coch. Voted unanimous.
