1 Call to order: Robert P. Valentine, First Selectman called the meeting to order at 5:03 p.m.

## 2. Approve the minutes of the January 7, 2020 Regular Meeting:

In a motion made by Dexter S. Kinsella, seconded by Mark S. Harris, it was voted to approve the minutes of the meeting of January 7, 2020 as presented. Voted unanimous.

## 4. Approval of Payroll and Warrant - January 16, 2020:

In a motion made by Mark S. Harris, seconded by Dexter S. Kinsella, it was voted to approve the total warrant and payroll for January 16, 2020 in the amount of $\$ 87,980.41$. Included in this warrant were the payroll in the amount of $\$ 14,579.27$ and the warrant in the amount of $\$ 73,401.14$. Voted unanimous. Included were payments for: MIRA (tipping fees): \$10,004.82; Morton Salt, (winter): $\$ 19,411.60 ;$ Sterling Health Ins. \$17,469.20; USA Hauling (recycling): \$7,330.50.

## 6. First Selectman's Report:

Bob Valentine attended a meeting in Hartford, wherein Tom Kirk, President of MIRA, clarified the elements of the contract (to upgrade the MIRA facilities), as required by State of Connecticut Department of Energy and environmental Protection, (DEEP) with Sacyr Rooney. (see minutes of $1 / 7 / 2020$ ).
This contract will have a substantial financial impact on the tipping fees from MIRA imposed on Connecticut municipalities. Currently, Goshen is under contract with MIRA until June, 2027. Under this contract, MIRA is obligated to dispose of MSW (Municipal Solid Waste) and recycling materials at a "cost of operation" to municipalities; Goshen is a Tier 1 municipality.

This contract/process was created by the legislature and made into law. Therefore, MIRA was required to work with Sacyr Rooney. Goshen's cost is $\$ 83.00$ /ton out to June 30,2020 and will increase to $\$ 91.00 /$ ton on July 1 , 2020; and may escalate to $\$ 145.00 /$ ton. The new contract will require $\$ 330$ million capital investment by MIRA. We will be receiving a "Memorandum of Understanding" from MIRA for a 30-year contract. This will require a Town Meeting to be ratified.

The board will have further discussion on the subject after Dexter and Mark have had time to view a CTN recording of Mr. Kirk's power point presentation next week.

Bob Valentine attended his first meeting at ACIR (Advisory Commission on Intergovermental Relations). This is a state government agency. Discussions were had on a previous draft report on municipal efficiencies, unfunded mandates and future proposals for enhancements.

Bob reported that much of his time this week has been spent conducting employee evaluations.
