# From the First Selectman

As summer winds down into fall, we must prepare ourselves for the winter season. We are experiencing higher inflation, causing higher prices for all essential items we need to survive - food, electricity, gas and oil prices, are at an all-time high. We look for alternative heat sources to heat our homes. Please have the Fire Marshal examine your woodstove and chimneys to prevent house fires. Also, have your heating systems evaluated for upgrades to make them run more efficiently.

The Selectmen and I are working on an EV Charger for the Town Hall parking lot. This will serve as a courtesy to the public and to the residents that rent their lake side homes during the summer months. These will be level 2 & 3, chargers will have credit card usage, so there's no cost to the town.

The Selectmen's Communication Task Force is working on a digital sign and newsletter to inform our residents of Town meetings and special events. Remember to visit the Town of Goshen's website, tap on the **How do I**? **Tab**, it will guide you wherever you want to go.

Our Animal Control Officers reported they had only three calls since May 1st, one dog, one cat and a bat. Our new Officers are working out quite well for us. Living with Bears: As I drive through Goshen on mornings of Monday or Tuesday, I see household garbage all over the streets which become a hazard for drivers with glass and other debris laying on the road. Plus, it is a pain to clean up after the bears. So, try to put your garbage container by the road the *morning* of pickup. Bears are creatures of habit, they know to come the night before pickup. Let's keep Goshen clean and **please don't feed the bears**.

Please continue to recycle and compost, MIRA (Materials Innovation and Recycling Authority) has raised our rates per ton to move our solid waste from Torrington to Hartford. We need to reduce the weight, so make your best efforts to recycle and compost.

Don't forget to sign up for the EMT course in September, contact Chief Hall to register. The Fire Company is still looking for new volunteers, so if you have the passion for saving lives, please contact Chief Hall for an application to the Fire Company.

### A Note From The Registrar of Voters Office:

• In the November 8th Election Connecticut voters will be voting for the following offices: U.S. Senate, U.S. House of Representatives, Governor, Lieutenant Governor, Attorney General, Secretary of State, Treasurer, Comptroller, State Senate, State House of Representatives, Probate Judge and Registrar of Voters. Now is the time to get to know the Candidates!

- There will also be a Ballot Measure (Question): Allow for Early Voting Amendment. Allowing the Legislature to provide for early voting.
- The November 8<sup>th</sup> Election will be held at Camp Cochipianee, The State of Connecticut completed redistricting in January. As a result Goshen has become one district once again. We will all be voting in one district which means we will all be going in the same door and going out the other door!!!
- As always if you are not able to vote in person there is always the option of an Absentee Ballot. The Town Clerk has provided information for voting by Absentee Ballot, just refer to the goshenct.gov website.
- The last day for in person and mail-in registration cut-off in ALL towns is Tuesday November 1, 2022. Hours 9 a.m. 8 p.m. (9-19b(d)) All mail-in voter registration applications must be received or post-marked by this date in order to be accepted. This is also the deadline to register to vote using the On Line Voter Registration System. Those whose rights as to age, citizenship or residence mature after the above date may apply in the office on a daily basis until the closing of the limited session on November 7, 2022 or at such limited session.
- LIMITED REGISTRATION SESSION THE LAST WEEKDAY BEFORE ELECTION. Session of Registrars of Voters of ALL towns to admit those seeking to vote in election whose qualification as to age, citizenship or residence was attained since November 1st. Hours: 9:00 a.m. 5:00 p.m. (9-17) NOVEMBER 7, 2022 (Monday)
- The Registrar of Voters are looking for people to work at the polling place. Schools will be closed. This is a great way for high school students (at least16 years old) or college students to make a little extra money and get some community service hours at the same time.
- As a reminder, if you are away at college, you may vote by absentee ballot.
- We have had several Questions from voters asking the same question. "If I am
  registered in a party do I have to vote for just that parties candidates?" The
  answer is no. In any election except a primary, a voter can choose to vote for
  any candidate regardless of party.

If you are not registered to vote, we encourage you to do so. Every vote counts to shape tomorrow. Please show support for Connecticut and get out and Vote!

#### LEGAL NOTICE

#### Town of Goshen Assessor's Office Personal Property Declarations

All persons conducting business in the Town of Goshen are required to return to the Assessor's Office, on or before November 1, 2022, a complete and accurate Declaration of all tangible personal property used in the conduct of their business as of the first day of October 2022.

Business assets include but are not limited to: manufacturing and industrial machinery and equipment; office fixtures, furniture, equipment and supplies; farm machinery and tools; mechanics tools; tools and equipment of your trade; electronic data processing equipment; cables and conduits; construction equipment and leased equipment.

All unregistered motor vehicles or motor vehicles registered out of state that are garaged in Goshen are taxable and must be declared, whether they are a business asset or a personal asset.

Any business or individual required to file a declaration may obtain the proper form from the Goshen Assessor's Office. Declarations will be mailed out in September. Failure to receive a form by mail does not excuse a property owner from filing.

### 2022 Revaluation

The Town of Goshen and Vision Government Solutions are working on the Analysis phase of the revaluation. As we approach October 1, 2022 the Field Review will begin. During this review, properties are viewed from the street by appraisers to double check uniformity and accuracy of the property information. When the review is complete and preliminary values have been set, a Notice of New Value will be mailed to each property owner in mid-November. At this time, anyone with questions concerning their value, the revaluation process or about the data on their property, will have the opportunity to schedule an informal hearing to discuss their property value.

A revaluation is required to be completed every five years. The purpose of this requirement is to insure uniformity in real property valuations by eliminating inequities that may have developed since the previous revaluation.

#### PROPERTY TAX EXEMPTIONS AVAILABLE IN GOSHEN

**Veterans Exemption**: To be eligible for this exemption, the veteran must have served during a period of war as specified in State Statute 27-103, have an honorable discharge and must file with the Town Clerk in the town of residence by September 30<sup>th</sup> a *Certificate of Release or Discharge from Active Duty* (DD-214). It is only necessary to file once for this exemption. Active duty military personnel are also eligible for this exemption and must file a letter stating active duty status by September 30<sup>th</sup> each year.

Goshen residents meeting the Basic Veteran's Exemption in accordance with State Statute 12-81(19) may be eligible for an additional assessment exemption if they meet certain income limits. Applications are available from the Assessor's Office and must be filed by October 1<sup>st</sup>. Once a veteran has been approved for this additional exemption, an application must be submitted every other year.

**Disabled Veterans Exemption**: To be eligible for this exemption, submit a copy of your Veteran's Disability Rating statement from the Veteran's Administration. Disabled veterans that have established their eligibility for this exemption are no longer required to file annually unless there is a change in the percentage of disability.

**Active Duty Vehicle Exemption**: A Goshen resident who is a member of the armed forces of the United States (including the reserves or Connecticut National Guard) on the October 1 assessment date may be eligible for the total exemption of one motor vehicle which is registered to or leased by the service person. Application is to be filed no later than December 31<sup>st</sup> following the property tax due date. Annual filing is required.

**Handicapped Equipped Motor Vehicles**: A local-option exemption is available for a specially equipped motor vehicle owned by a person with disabilities or owned by the parent or guardian of a person with disabilities.

**Exemption for Blindness**: To receive a \$3,000 assessment exemption, certification of blindness must be obtained from the State of Connecticut, Board of Education and Services for the Blind. This certificate must be dated and filed with the Assessor by October 1<sup>st</sup>. It is only necessary to file once for this exemption.

**Exemption for Totally Disabled**: To receive a \$1,000 assessment exemption, proof of permanent total disability from the Social Security Administration and a signed Form D-1 Application must be submitted to the Assessor by October 1<sup>st</sup>. It is only necessary to file once for this exemption.

Any qualifying exemptions will be applied to the following July tax bill.

#### **GOSHEN SPECIAL USE ASSESSMENTS**

**Farm, Forest and Open Space**: Owners wishing to classify land as farm, forest or open space should contact the Assessor's Office for details and applications. All applications must be filed with the Assessor's Office between September 1<sup>st</sup> and October 31<sup>st</sup>.

#### **REAL ESTATE ESCROW FOR TAXES**

If you pay off your mortgage, you MUST notify the Tax Collector's office so that we may update your account and send you a bill; otherwise your bills will continue to go to the mortgage company.

#### **IRS Tax Preparation**

**How do I find out how much I paid to the Town of Goshen (Real Estate & Personal Property) in 2022?** Your Real Estate and Personal Property tax payment history is available on the Town Website; <a href="www.goshenct.gov">www.goshenct.gov</a>, go to the Tax Collector's page to search for the taxes paid in calendar year 2022.

- All requests for taxes must be submitted in writing or emailed with a selfaddressed stamped envelope or return email address.

#### **DMV**

DMV now has an interactive website that allows you to complete numerous tasks from your home or a public computer which will eliminate some long waits at the DMV.

- Cancel Registration and License Plates (you do not have to mail plates to DMV)

- Renew Registration, Reprint Registration Certificate
- Replace Damaged License Plates

#### **MOTOR VEHICLE RELEASES**

If you are overdue on your motor vehicle taxes and can't make it into the Tax Office, pay on-line at <a href="www.goshenct.gov">www.goshenct.gov</a>. Go to the Tax Collectors page to find the link for online payments. After the payment is processed you can obtain a Motor Vehicle Release from the Tax Collector. Please call the Tax Office during regular business hours for details as the release still needs to be processed by the Tax Collector. For after hours release, email <a href="mailto:taxcollector@goshenct.gov">taxcollector@goshenct.gov</a> to get a quicker response.

# Re: Sequence of Events for Construction of Dwelling, Addition, Pool or Accessory Building in the Town of Goshen

Please be advised that new dwellings, additions, barns, garages, decks and EVEN "COVER-IT TYPE SHEDS" ALL REQUIRE ZONING PERMITS. The Zoning Regulations, Town Ordinances and Land Use applications are all available online at <a href="https://www.goshenct.gov">www.goshenct.gov</a>. For your convenience, the Town of Goshen has adopted online permitting for the submittal of land use permit applications. Paper applications will no longer be accepted. To use the PermitLink online permitting program, you must first create a login account. Once your login account is created, you can use it for all land use and building permit-related applications you may wish to submit. If you need assistance using a computer, there is one available at the Goshen Town Hall.

Here is a summary of the various steps involved for obtaining the required approvals:

- 1. For a new house have a soil scientist flag any wetlands on the lot and have an engineer/surveyor develop a site plan that shows the proposed house, driveway, sewer line or septic system, well location and any wetlands or watercourses located by the soil scientist. Contact Torrington Area Health District at (860) 489-0436 for a list of soil scientists.
- 2. For a new house obtain approval from the Torrington Area Health District for the proposed septic system and well location. Lots inside the Woodridge Lake Sewer District and RA-1 Zone, require approval from the Torrington Area Health District for the proposed well and a Sewer Connection Permit from the Woodridge Lake Sewer District Administrator, (860) 491-3474. If there is a septic system on your lot, the Health District must approve all additions, decks, and accessory buildings. The Health District has a separate pool application permit that must be obtained for all new swimming pools. Contact Richard Rossi, Sanitarian, at Torrington Area Health District at (860) 489-0436.
- 3. Obtain an Inland Wetlands Permit from the Goshen Inland Wetlands Commission for any work proposed within 100' of a wetlands or watercourse (the regulated inland wetlands areas.) The Commission regulates construction, filling, and removal of materials within the regulated wetlands and watercourse area. Contact Martin Connor, Town Planner, Zoning and Wetlands Enforcement Officer on Tuesday or Thursday mornings between 7:30 a.m. and 9:45 a.m. at 491-2308 ext. 232. The Inland Wetlands Commission meets the first Thursday each month at 7:15 pm, Goshen Town Hall. Applications should be submitted one week prior to a meeting.
- 4. Obtain a driveway permit from the Public Works Supervisor, Garrett Harlow at (860) 491-6029 for all new driveways and repairs to driveways. The Town's driveway regulations are contained in the Town's driveway ordinance that was recently revised. Mr. Harlow also assigns addresses on new houses.

5. Obtain a Zoning Permit from Martin Connor, Town Planner/Zoning and Wetlands Enforcement Officer, for proposed houses, additions, decks and accessory buildings including "cover-it" garages. The required zoning setbacks for the WL - Woodridge Lake Zone are 20' front and rear and 20' on the sides (75' from the lake.) Lots in the RA-2 and RA 5 Zones are 50' front and rear, 30' setback on the sides (75' from Tyler Lake, Dog Pond and Westside Pond.) The RA-1 Zone requires a 50' front and rear yard setback and 20' on the sides. Pools, decks and accessory buildings all require Zoning and Building permits and must meet the minimum zoning setback requirements. Maintenance sheds under 150 square feet can be built in all zones no closer than 10' from side and rear property lines (Woodridge Lake Deed Restrictions require a minimum of 20'.)

6. Obtain a Building Permit from Chris Zibell, Building Official. (860) 491-2308 ext. 231. Please use the Town's new on-line building permit application system. Mr. Zibell is available on Tuesday and Thursday mornings, 7:30 a.m. to 10:00 a.m.

#### PUBLIC WORKS DEPARTMENT

The Public Works Department strives to help improve the appearance and maintenance of roads and town property. This could not be done without the hard work of the highway crew.

#### \*NEW STONE WALL ORDINANCE\*

Town Ordinance Title 73, Ordinance Concerning Highway Boundary Stone Walls has been enacted. The ordinance is posted on the Town website ordinance page for review. A permit must be applied for at the Public Works Department (permit is also available for download on the Public Works page of the Town website) prior to performing any work on, the relocation of, or the removal of, a highway boundary wall lining Town or State roadways within the limits of Goshen. If you have any questions, or would like to apply for a permit please contact the Public Works Department at 860-491-6029 or by e-mail at publicworks@goshenct.gov.

#### **CAPITAL AND ROAD IMPROVEMENT PROJECTS**

This summer season Public Works has continued working on the road plan with the rebuilding of several sections of West Hyerdale Dr. including from Shelbourne Dr. to Canterbury Ct., from Bentley Cr. to Allenby Ct. and from #244 to Weldon Ct.; additionally we are rebuilding Canterbury Ct., and Allenby Ct. Repairs and replacement of drainage systems are also being made in other locations in Town. High demand along with high prices have made this a particular challenge. We will continue drainage projects on select roads into the fall.

#### DRIVEWAY ORDINANCE AND PIPE MAINTENANCE

Title 18, the Town of Goshen Driveway Ordinance Concerning the Construction of Driveways, including temporary access driveways on Town roadways. The ordinance also covers the maintenance of driveways. A permit must be applied for at the office of Public Works prior to the start of construction of a new driveway, or the repaving, re-grading or drainage improvements being performed to an existing driveway, if any of the proposed work is to take place in the Town right-of-way. A cash bond will need to be posted by the property owner or contractor performing the work. The bond amount will be calculated at the time of application based upon the probable cost of the work to be performed in the right-of-way. There is no permit fee for a driveway application. Please see Ordinance Title 18 for more information or contact Public Works at 860-491-6029 or by email at <a href="mailto:publicworks@goshenct.gov">publicworks@goshenct.gov</a> with questions or to apply for a permit.

Additionally, the ordinance requires that property owners with a cross pipe under their driveway or other drainage system, maintain it in a functional condition. Please make the cleaning out and inspection of your drainage pipes to allow for the free flow of water part of your fall property cleanup. Thank you for your cooperation in this important matter.

#### **UPCOMING MAINTENANCE AND PROJECTS**

The Public Works Department will be regrading the dirt roads in the coming months to ready them for winter. Additionally leaves will be blown from the roadside ditches to keep them clear to allow for the flow of water after the ground freezes. Please do not deposit leaves or any other materials in the roadside ditches as the Town does not pick up leaves. The ditches need to remain clear to effectively drain water away from roads and properties. Brush and vegetation clearing from Town owned right-ofways is an ongoing project. This work is performed to keep clear sightlines along roads and to keep vegetation with accumulated snow loads from hanging into roadways, creating a hazard to motorists. Additionally, the department has started the tasks associated with mechanically readying our fleet of trucks and heavy equipment for the upcoming winter season.

#### FALL/ WINTER SEASON SAFETY


Although the Public Works Department is careful about their surroundings while plowing and treating the roads, please be aware when you are in proximity of these working vehicles, especially due to their limited rear-view vision. Rear view blind spots can extend back 100'on a truck. Please give us sufficient room to work and assume the driver does not see you! We all thank you for your cooperation on this important matter of safety. Additionally, please make every effort to keep your trash and recycling totes off of the edge of the roadways for the safety of roadway users.

#### WINTER SAND FOR RESIDENTS

Starting in November, winter sand is available to Goshen residents only, and in small quantities. It will be located at the Public Works garage next to the red barn at 38 Torrington Road. Be noticed the sand pile is monitored.

#### **MAILBOX DAMAGE**

The Public Works Department is not responsible for damage to mailboxes unless one of our vehicles directly inflicts damage to the mailbox. Should snow or debris damage the mailbox as a result of plowing, the Public Works Department is not responsible for replacement or repair.

#### The Caroline T. Brooks Fund

The Caroline T. Brooks Fund was established under the Will of Alice L. Carlisle, who was a resident of the Town of Goshen. The purpose of the Fund is to provide medical care for the children of the Town of Goshen (particularly for their eyes, ears, noses, throats and teeth), whose parents or guardians are unable to afford such care and treatment.

Parents or guardians who have been residents of the Town of Goshen for at least twelve months may complete an application for any child under age 18 or under who is a Goshen resident.

Applications are available at the First Selectman's office, Town of Goshen, and at The Goshen Congregational Church and are accepted on a rolling basis.

Applications will be considered by a committee consisting of the First Selectman of the Town of Goshen, the minister of The Goshen Congregational Church and a Trust Officer of Bank of America as provided under the terms of the Will. The committee reviews applications approximately every other month (or as needed).

Decisions are based on the financial need of the family and any personal or extenuating circumstances (such as an unemployed parent). The committee considers monthly net cash flow, adjusted gross income from the tax return and liquid assets, when evaluating the financial need of an applicant.

# Sustainable Goshen



"Never doubt that a small group of thoughtful, committed citizens can change the world; indeed, it is the only thing that ever has."

- Margaret Mead

Several years ago, a very small group of committed citizens began talking about Goshen working for a Sustainable CT Bronze Certification. The pandemic put those talks on hold, but last winter they were renewed and the small group became a little bigger and louder and busier and on August 22<sup>nd</sup> Goshen submitted an application of 275 points for review for the Bronze.

The application will be evaluated by twelve different reviewers, many of them volunteers that are experts in their category. They will determine if an action is complete and acceptable towards certification. 200 points are required for Bronze Certification, with the caveat that at least one action in every category is complete. Review is a long process and notification will probably take until early November. Meanwhile a growing group of committed citizens is still working to make Goshen an even better place to live, work, and play.

A lot has been accomplished. Using the application process of looking at our town through multiple lenses, we have seen so much to be proud of - We live in a GREAT Town! - and we have seen ways that we could work together to improve it. We will talk more about our ideas for projects, available grant moneys and working toward Silver Certification over the next year, but first let's celebrate Goshen and be thankful for the many people who helped us get this far (while we cross our fingers and wait...).

Our town government has been incredibly helpful in supporting the Sustainable Goshen Team in its work. We are very lucky to live where every town employee is courteous and available to residents. Heartful thanks goes out to everyone in the Town Hall, Public Library, Recreation Department, Town Planner and Public Works who answered questions or steered us where we needed to go. An especially big thank you goes to First Selectman, Todd Carusillo and office administrator, Virginia Perry. Both have a lot on their plates, but always respond to resident phone calls or quick town hall visits with professionalism and efficiency.

The fact is most of the work was to document what was already here. Due to thoughtful planners and leaders in the past, Goshen has policies and practices that will earn us most of the points required for Bronze Certification. There were some things the town accomplished that while they may have been an idea before, Sustainable helped make happen.

- In early June residents representing town commissions, committees and local non-profits attended our first Community Conversation that helped identify ways to improve our town. Look for another Sustainable Goshen Community Conversation this fall!
- People stepped up to plant pollinator gardens and support a town resolution that established Goshen as a part of the national Pollinator Pathway.
- Residents came out to an invasive plant workshop at Camp Cochipianee sponsored by the Conservation Commission and Goshen Land Trust to learn about invasive plants and how to control them.

• The Economic Development Committee carefully reviewed the Green Bank/C-PACE program before recommending the town sign a resolution/agreement to allow local businesses to have access to funding opportunities to make their businesses more energy efficient (Local Business Owners, watch for an invitation this fall from the Goshen Business Circle to attend information meetings with Green Bank.)

Sustainable Goshen didn't originate some ideas, but actively supported them:

- So many people collected plastic film that our RATS committee reached their goal of '500 pounds = a new Trex bench' for Scoville Park in less than half the time! Keep collecting that plastic! You can recycle it directly at your grocery store and many big box stores. Easy to drop off a bag full as you walk into the market.
- Many folks planted the native wildflower seeds we distributed to support the Goshen Public Library's new Seed Library. (Did you collect any seeds from your garden this year? How about helping to 'seed' the Seed Library with some?)
- The Communication Task Force followed the Sustainable CT recommended process to examine current town communication and create a plan to increase engagement with residents and our town's work.

So, through all this what did we learn about Goshen? Virtually every resident we talked to is proud of our town. Many people want to help with our work and that is amazing! We will need a lot of help with coming projects as we work towards Silver Certification. Have an idea? Want to be a part of a growing group of committed citizens? 


