

## From the First Selectman

The transition from November 12, 2021 until this article is off to print has been smooth especially with the great team in place. At this point, I would like to thank Bob Valentine for the sixteen years of dedicated service to our town.

In 2011, Goshen was divided into two different electoral districts, which caused a lot of headaches and expense to our town. Goshen is no longer split between two districts, the 63<sup>rd</sup> and the 64<sup>th</sup>. Now we are the 64<sup>th</sup> House District and our state representative is Maria Horn. This will benefit Goshen with savings of election expenses.

With regards to the new infrastructure bill, Connecticut will be receiving 8% of \$100 million for Broadband. The northwest corner of the state will be receiving 17% which equals \$40 million. The Selectmen and I will be working to create a Broadband Advisory Committee. This Committee will be reporting back to me with their findings. My goal is to get every Goshen resident the fastest internet service available.

Throughout this pandemic, the past administration has kept our residents informed with the very latest updates and news concerning the COVID 19. As your new First Selectman, I will be providing new updates at our Board of Selectmen meetings. As of today, November 23, 2021, there are 6 cases throughout Litchfield County.

Goshen's Recreation Department is celebrating their 50<sup>th</sup> Anniversary. Don't hesitate to contact our Recreation Director, Katie Hennessy for information on new programs, in particular the new health and fitness programs for this winter season.

We are entering into the new holiday season with an influx of new traffic at the "rotary". I have contacted the State Police at Troop B in Canaan for increased presence at the center. Having said this, I urge everyone to be careful when entering the circle. I want everyone to be safe in their travels. Remember to enjoy your family and friends this holiday season.

# REMINDER 2<sup>ND</sup> INSTALLMENT DUE ON PROPERTY TAXES Last day to pay <u>without</u> penalty: Tuesday, February 1, 2022

Pursuant to Sec. 12-145 of the Connecticut statutes, the undersigned Tax Collector of the Town of Goshen gives notice that she will be ready to receive Supplemental Motor Vehicle taxes and the second installment of Real Estate & Personal Property taxes due January 1, 2022 at the Tax Collector's office in the Goshen Town Hall, 42A North St, Goshen, CT on Tuesdays from 9:00 – Noon and Wednesdays 1:00 – 4:00. Payments must be received or postmarked by Tuesday, February 1, 2022 to avoid interest.

Don't wait till the last day to mail your payment. It may take the postal service up to 24 hours to deliver your mail to a distribution center where the postmarks are added.

Ask postmaster to hand stamp postmark on the last day of the month.

Online banking through your personal bank – these payments are NOT postmarked and they are often NOT received till after date you requested. They will be late if received on Feb. 2<sup>nd</sup>!

All taxes remaining unpaid after February 1, 2022 will be charged interest from January 1, 2022 at the rate of 1.5% for each month elapsing from the due date of the delinquent tax to the date of payment, with a minimum interest charge of \$2.00. Sec. 12-146

Failure to receive a tax bill does not relieve the taxpayer of his/her responsibility for the payment of taxes or delinquent charges. Sec. 12-130

- Credit Cards: Point & Pay charges a 2.9% convenience fee, \$2.00 min.
- Debit Cards: Point & Pay charges flat fee of \$3.95 for payment processing.
- E-checks/ACH payments: Point & Pay charges fee of \$2.95 if the payment is less than or equal to \$10,000.00 and \$10.00 for each payment that is greater than \$10,000.00.

### TOWN OF GOSHEN BOARD OF ASSESSMENT APPEALS

Taxpayers wishing to appeal assessments on the October 1, 2021 Real Estate and/or Personal Property List, or the 2020 Supplemental Motor Vehicle List, must make a written request to the Board of Assessment Appeals for a hearing. This written request must be submitted on the prescribed form and received by the Board of Assessment Appeals, Goshen Town Hall, 42A North Street, Goshen, CT, 06756 no later than **February 20, 2022.** 

Forms to be used for filing appeals can be found on the Town of Goshen website <a href="https://www.goshenct.gov/board-of-assessment-appeals">www.goshenct.gov/board-of-assessment-appeals</a>. Taxpayers wishing to obtain a form by mail may call 860-491-2115. A separate form is required for each property being appealed.

The Board of Assessment Appeals will notify taxpayers in writing of the date, time, and place of their hearing. Hearings will be held in mid-March at a time and place to be determined.

When completing the required form, taxpayers are strongly urged to name an agent to act on their behalf in the event they cannot keep the scheduled appointment.

An appeal cannot be heard unless the required written request is received by the Board of Assessment Appeals on or before **February 20, 2022.**

### **PUBLIC WORKS DEPARTMENT**

The Public Works Department strives to help improve the appearance and maintenance of roads and town property. This could not be done without the hard work of the public works department staff.

### **!!PARKING BAN!!**

There is a <u>Parking Ban on Town Roads</u> during winter weather storm events between <u>November 1st and April 1st.</u> (Town Ordinance Title 17, <u>www.goshenct.gov</u>). Vehicles and trailers left on the roads during these times <u>may be towed at the owner's expense.</u>

### \*NEW STONE WALL ORDINANCE\*

Town ordinance Title 73, Ordinance Concerning Highway Boundary Stone Walls has been enacted. The ordinance is posted on the Town website ordinance page for review. A permit must be applied for at the Public Works Department (permit is also available for download on the public works page of the Town website) prior to performing any work on, the relocation of, or the removal of a highway boundary wall lining Town roadways within the limits of Goshen. ### **CAPITAL AND ROAD IMPROVEMENT PROJECTS**

The past construction season was again a busy one for the public works department. In addition to working on many road projects over the spring and summer months. The Public Works Department continued to replace drainage pipes in areas throughout Town. Additionally a large drainage project was completed this fall by an outside contractor. The project also included planned storm water quality upgrades. Public Works will continue the process of planning for next year and beyond improvement projects through the winter months.

### WINTER SEASON SAFETY

<u>Please make every effort to keep your trash and recycling totes off of the edge of the roadways for the safety of roadway users and to allow for the plowing of roads during storms.</u>

Although the Public Works Department is careful about their surroundings while plowing and treating the roads, please be aware when you are in proximity of these working vehicles, especially due to their limited rear-view vision. Rear view blind spots can extend back 100'on a truck, please give us sufficient room to work and assume the driver does not see you! We all thank you for your cooperation on this important matter of safety.

Any job site the Public Works Department is working at is considered a **WORK ZONE** and **FINES** will be **DOUBLED**. This includes crews cutting vegetation along the roadsides. Please drive slowly and cautiously by these areas. If possible, please find an alternate route until work is completed.

### WINTER SAND FOR RESIDENTS

Winter sand is available after November 1<sup>st</sup> to Goshen residents in small quantities at the Public Works facility. Sand is located in the bin next to the red barn at 38 Torrington Road. Be warned the area is under monitor.

### **MAILBOX DAMAGE**

The Public Works Department is not responsible for damage to one's mailbox unless one of our vehicles direct impact causes damage to the mailbox. Should snow or debris damage the mailbox as a result of plowing, the Public Works Department is not responsible for replacement or repair.

### DRIVEWAY ORDINANCE AND PIPE MAINTENANCE

Title 18, the Town of Goshen Driveway Ordinance concerning the construction of driveways including temporary access driveways on Town roadways. Additionally, this ordinance covers the maintenance of driveways. A permit must be applied for at the office of Public Works prior to the start of construction of a new driveway, or the repaving, re-grading or drainage improvements being performed to an existing driveway if any of the proposed work is to take place in the Town right-of-way. A cash bond will need to be posted by the property owner or contractor performing the work, the bond amount will be calculated at the time of application based upon the probable cost of the work to be performed in the right-of-way. There is no permit fee for a driveway application. Please see Ordinance Title 18 for more information or contact Public Works at 860-491-6029 or by email at <a href="mailto:publicworks@goshenct.gov">publicworks@goshenct.gov</a> with questions or to apply for a permit.

Additionally the ordinance requires that property owners with a cross pipe under their driveway or other drainage system maintain it in a functional condition. Thank you for your cooperation in this important matter.

### Re: Sequence of Events for Construction of Dwelling, Addition, Pool or Accessory Building in the Town of Goshen

Winter is here and many residents are planning spring and summer projects. Please be advised that dwellings, additions, barns, garages, decks and EVEN "COVER-IT TYPE SHEDS" ALL **REQUIRE ZONING PERMITS.** The Zoning Regulations, Town Ordinances and Land Use applications are all available online at www.goshenct.gov. For your convenience, the Town of Goshen has adopted online permitting for the submittal of land use permit applications. Paper applications will no longer be accepted. To use the 4. PermitLink online permitting program, you must first create a login account. Once your login account is created, you can use it for all land use and building permit-related applications you may wish to submit.

Here is a summary of the various steps involved for obtaining the required approvals:

- 1. For a new house have a soil scientist flag any wetlands on the lot and have an engineer/surveyor develop a site plan that shows the proposed house, driveway, sewer line or septic system, well location and any wetlands or watercourses located by the soil scientist.

  Contact Torrington Area Health District at (860) 489-0436 for a list of soil scientists.
- 2. For a new house obtain approval from the Torrington Area Health District for the proposed septic system and well location. Lots inside the Woodridge Lake Sewer District and RA-1 Zone, require approval from the Torrington Area Health District for the proposed well and a Sewer Connection Permit from the Woodridge Lake Sewer District Administrator, (860) 491-3474. If there is a septic system on your lot, the Health District must approve all additions, decks, and accessory buildings. The Health District has a separate pool application permit that must be obtained for all new swimming pools. Contact Richard Rossi, Sanitarian, at Torrington Area Health District at (860) 489-0436.
- 3. Obtain an Inland Wetlands Permit from the Goshen Inland Wetlands Commission for any work proposed within 100' of a wetlands or

- watercourse (the regulated inland wetlands areas.) The Commission regulates construction, filling, and removal of materials within the regulated wetlands and watercourse area. Contact Martin Connor, Town Planner, Zoning and Wetlands Enforcement Officer on Tuesday or Thursday mornings between 7:30 a.m. and 9:45 a.m. at 491-2308 ext. 232. The Inland Wetlands Commission meets the first Thursday each month at 7:15 pm, Goshen Town Hall. Applications should be submitted one week prior to a meeting.
- 4. Obtain a driveway permit from the Highway Supervisor, Garrett Harlow at (860) 491-6029 for all new driveways and repairs to driveways. The Town's driveway regulations are contained in the Town's driveway ordinance that was recently revised. Mr. Harlow also assigns addresses on new houses.
- 5. Obtain a Zoning Permit from Martin Connor, Town Planner/Zoning and Wetlands Enforcement Officer, for proposed houses, additions, decks and accessory buildings including "cover-it" garages. The required zoning setbacks for the WL - Woodridge Lake Zone are 20' front and rear and 20' on the sides (75' from the lake.) Lots in the RA-2 and RA 5 Zones are 50' front and rear, 30' setback on the sides (75' from Tyler Lake, Dog Pond and Westside Pond.) The RA-1 Zone requires a 50' front and rear yard setback and 20' on the sides. Pools, decks and accessory buildings all require Zoning and Building permits and must meet the minimum zoning setback requirements. Maintenance sheds under 150 square feet can be built in all zones no closer than 10' from side and rear property lines (Woodridge Lake Deed Restrictions require a minimum of 20'.)
- 6. Obtain a Building Permit from Chris Zibell, Building Official. (860) 491-2308 ext. 231. Please use the Town's new on-line building permit application system. Mr. Zibell is available on Tuesday and Thursday mornings, 7:30 a.m. to 10:00 a.m.

Why add to the Plan of Conservation and Development (POCD) an amendment to include the already existing Town Affordable Housing Plan. Let's examine the Reasons.

"The Goshen Planning and Zoning Commission under the provision of the Town ordinance is charged with the responsibility to adopt, amend and administer the Town Zoning and Subdivision Regulations. That authority is granted to the Town by the State of Ct under Connecticut General Statutes, Chapter 124 & 126. Chapter 126 required the Commission to prepare and adopt a POCD at least every 10 years.<sup>1</sup>

"The Goshen Plan of Conservation and Development is a comprehensive statement of the Town's future direction. It is an advisory set of land use guidelines for the Planning and Zoning Commission. It can be found at <a href="https://www.goshenct.gov/sites/g/files/vyhlif626/f/file/file/adopted2016pocd.pdfm">https://www.goshenct.gov/sites/g/files/vyhlif626/f/file/file/adopted2016pocd.pdfm</a> In it, page 4, item 2 states; "Expand housing opportunities and design choices to accommodate a variety of household types and needs." On pages 18-20 the POCD goes on to include recommendations on the subject. The current plan was adopted in 2016.

A State law passed in 2017(CGS 8-830j) requires every municipality to prepare or amend and adopt an affordable housing plan at least once every five years.

Recently the Board of Selectmen created a working group to formulate a plan in compliance with CGS 8-30j. After months of work and two public hearings on the subject the Board of Selectmen adopted a comprehensive plan that not only address the requirements of state law but also dose it in a way that takes in to consideration the needs of Goshen and its residents.

Why amend the POCD to include the recently adopted Affordable housing Plan? First, by adopting the affordable housing plan as an amendment to the current POCD, the Planning and Zoning commission will extend the current plan for another ten years. Second, the POCD as currently constituted lacks specific details on how Goshen would potentially implement strategies for creating affordable housing that fits Goshen's needs.

There are some who would have you believe if we don't adopt the Affordable Housing Plan as part of our POCD Goshen will be able to keep affordable housing from being created in town. Unfortunately, for that to be true one would have to believe that Goshen has the ability to ignore the reality of the tides of change that are coming from Hartford, tides that will dictate how, when and where Goshen implements housing that is affordable. Mandating things that are neither appropriate nor in keeping with our small-town community. And, and not a small and, that we are exempt from current state law that can and will limit our P&Zs ability to manage the creation of housing that is affordable and Goshen centric rather than Hartford centric.

Others believe that if the individuals who worked on the current plan, as requested by the Board of Selectmen and required by state law, are somehow diminished by false accusations of conflicts, then they can keep the plan from being implemented all together. Being persistently loud with false and misleading information is neither appropriate or in the best interests of our community.

Make no mistake, affordable housing is happening currently in Goshen and will happen in the future. The only question is will we as residents have a say on how it is developed.

By adopting the current Affordable Housing Plan as part of the POCD we will ensure that Goshen determines its future as it related to affordable housing and not Hartford legislators.



### Goshen Land Trust Earns National Recognition

One thing that unites us as a nation is land: Americans strongly support saving the open spaces they love. Since 1980, the Goshen Land Trust has been doing just that for the people of Goshen. Now the Goshen Land Trust has announced it has achieved national recognition – joining a network of over 450 accredited land trusts across the nation that have demonstrated their commitment to professional excellence and to maintaining the public's trust in their work through the Land Trust Accreditation Commission.

The Land Trust Accreditation Commission inspires excellence, promotes public trust and ensures permanence in the conservation of open lands by recognizing organizations that meet rigorous quality standards and strive for continuous improvement. The Commission, established in 2006 as an independent program of the Land Trust Alliance, is governed by a volunteer board of diverse land conservation and nonprofit management experts. For more, visit www.landtrustaccreditation.org.

"Accreditation demonstrates the Goshen Land Trust's commitment to permanent land conservation in Goshen." Said Barry Donaldson, president. "We are a stronger organization for having gone through this rigorous process. Our accreditation gives residents the assurance that the land in the Goshen Land Trust's care will be protected forever."

This accomplishment was achieved through the hard work of a team of volunteers and a generous grant from the Northwest Connecticut Community Foundation. The \$7,000 grant subsidized expert help throughout the process. The committee worked for a year with an attorney who guided the team through the Standards and Practices requirements and a licensed Ecology Forester who helped complete the extensive land management documentation needed to qualify.

Over the years, the Land Trust has secured ownership of over 510 acres of land and conservation easements on an additional 183 acres. Much of this land is along stream corridors with wild beauty and historic mill sites. Residents and visitors are invited to hike our trails all year and enjoy our protected forests, meadows and streams. From the Monarch Sanctuary



The Monarch team has worked well into November to finish its 2021 goal of soil preparation, laying out and completing walks and garden patterns.

Our eastern Monarch butterflies have left for Mexico and are now hibernating by the millions in the Sierra Madres Mountains on the west coast of Mexico!

Next spring, they will again begin the most amazing migration on this planet, their multi-generational journey north! We will be expecting their  $2^{nd}$  or  $3^{rd}$  generation arrival here in Goshen when it gets warm, sometime in May or early June. We expect many to come and visit the blooming milkweeds and nectar plants in their new and growing Sanctuary here in Goshen!





Nectar plants had been established in spring. This fall, the meadow areas were seeded, a drainage area dug and filled with appropriate stones, 50 yards of edging put in place and 41 swamp milkweed, Joe Pye Weed and other perennials were fall planted. The goal for the Year was met!

The Monarch Sanctuary was honored by receiving the 2021 award for Pollinator Protection from the Northwest Connecticut Conservation District!



Our goal for 2022 is to establish an area of butterfly and wildlife friendly native trees and shrubs on the moist east end field, complete the edging on the northside, assess and find solutions for drainage issues and replace the plants that did not winter well.

Winter is now upon us and the soil is resting, the seeds are preparing to sprout in spring.


