Dear Mr. Dziedic:

I received a complaint regarding a sea wall & steps constructed within 100 feet of a wetlands and watercourse, Woodridge Lake, on the property above without the necessary approvals from the Goshen Inland Wetlands Commission. Such work constitutes a regulated activity pursuant to Section 6.1 of the Town of Goshen Inland Wetlands Regulations. Connecticut General Statutes Sections 22a-36 through 22a-45 requires that a permit be obtained prior to conducting regulated activities affecting inland wetlands and watercourses. A review of our files indicates that no permit was issued for the work described above. Accordingly, such work has been conducted in violation of the law.

You are hereby directed to:

- 1. Discontinue any further activity within the regulated inland wetlands area.
- 2. Seed and mulch the disturbed areas within 10 days.
- 3. Provide a written reply to this notice within thirty (30) days, explaining the nature of the work and why no permit was obtained from the Goshen Inland Wetlands Commission.
- 4. File an After-the-Fact Inland Wetlands Application. The application is available online at https://www.goshenct.gov/inland-wetlands-and-water-courses-commission/pages/land-use-online-permitting-system-guidelines.
- 5. Appear before the Goshen Inland Wetlands Commission at their next scheduled meeting

Thursday, June 1, 2023, at 7:15 pm. The meeting will be held live at Town Hall and via Zoom.

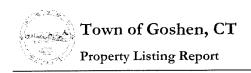

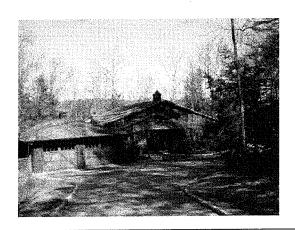

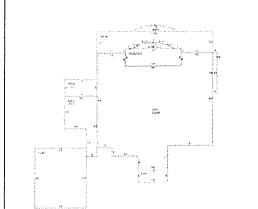
