Town of Goshen, Site Plan Application, 190 Sharon Turnpike, Construct 190' x 85' vehicle and equipment storage building for use by the Town of Goshen and Goshen Fire Department: Met with Garrett Harlow, Public Works Director, Town of Goshen, who filed a Site Plan application to construct a vehicle and equipment storage building for use by the Town of Goshen and Goshen Fire Department. Per Section 3.3.3.1.5 of the Zoning Regulations, uses by the Town of Goshen, including public safety facilities, are permitted principal uses in the RA-2 Zone. Reviewed plans with Project Engineer Bill Coby, P.E. Asked for additional information to make the application complete. Reviewed revised plans and documents. Wrote memo to the Commission recommending Site Plan approval for this permitted use as it complies with the Regulations.
