Fire Chief's Report: Chief Barry Hall reported that in May there were 17 EMS calls, 3 fire alarm calls, and 2 MVC calls for a total of 22 calls this month and there are several events coming up that GFC will be on standby for. Open house went over well, Lori Clinton gave a brief summary of the event (approx 80 visitors, \$530 in donations, and 3 new Associate Members). Lisa Foster asked about signage for GFC and the electronic sign was mentioned as other options and how to get new members. Truck committee has met 3 times and Pierce came for a visit and they came up with some ideas (will be more like Engine 3 but a bigger tank and a compressed air foam system). We are looking at between \$750-800 thousand with a 2 year build, but the bid would be locked in for 23 months and looking at 8% increase on price in September. We are open to other companies for the new Engine. Not sure if the Ambulance committee has met and if we will go with LifeLine again. Insurance policy up for renewal July 1st and meeting with the 2 companies that provide coverage. We will be hosting another EMT class and coming up with other ways to make it successful for students to pass the written and practical.
