Call Meeting to Order: Bill Lane called the meeting to order at 7:04PM.

Reading of the Minutes: The minutes of the regular meeting of February 2, 2022 were

reviewed by the Commissioners.

**IN A MOTION** made by Tony Damiani and seconded by Bill Lane, it was **VOTED** to accept the minutes from the February 2, 2022 regular meeting as submitted. Motion carries.

**Fire Chief's Report**: Chief Barry Hall reported that the EMS class is finished and students are preparing for the practical on Saturday, March 5. They will then be able to take their written test. We are closer to having some more EMT's join our crew. The Company is always looking for Fire and EMS volunteers to join.

The Company responded to 35 calls in February, 30 EMS, 1 MVA, and 4 assorted Fire calls. EMS has been very busy again this month. It seems as call load is increasing which could effect the budget but that remains to be seen. Just something to keep in mind..

Fire Marshal's report: The report for February 2022 was read by the Clerk.

**Bills:** All qualifying bills were reviewed on report provided by the Clerk, vouchers were signed and approved for payment.

**Old Business:** Finalize budgets for submittal. Discussion on items Chief reviewed from last meeting. Pagers for the new EMT's are going to be purchased. The pager line item budget looks good to cover those new purchases. The hose cost \$1,700 for 3 lengths. The Company had 7 lengths fail at last inspection. Barry noted that the Capital request for Hose should be \$4,000 22/23FY and \$2,000 for each year in the 5 year plan to 27/28FY. Discussion of Engine and Ambulance replacement costs. Discussion on need to add a line item for oil furnace/burner replacement. The Clerk requested a quote to get a baseline number to budget over 5 years but was not provided with one in time for this meeting. It was decided to start with \$1,000 for 22/23FY on a new line item titled "Furnace replacement" and go forward with \$2,500 per year in the 5 year plan to 27/28FY until a solid number can be obtained.
