

**Town of Goshen
Inland and Wetlands Commission
Regular Meeting Minutes
Thursday, April 6, 2023 7:15PM**

1. Call Meeting to Order: Mr. Stansfield called the meeting to order at 7:15PM. The meeting was conducted in person at Goshen Town Hall.

2. Reading of the Minutes: The minutes of the regular meeting of March 2, 2023 were reviewed by the Commissioners.

MOTION by Mr. Turri and seconded by Mr. Wadhams, it was VOTED to accept the minutes from the March 2, 2023 regular meeting. Motion carries.

5. OLD BUSINESS:

- A. Woodridge Lake Property Owners Association, 260 E. Hyerdale Drive - add 20 foot tie up moorings to the picnic area -** Mr. Connor reviewed the required items and that they had all been addressed. Mr. Koenig had concerns with contamination of bringing over the concrete and the removal of the soil. Mr. Hay addressed those concerns with the concrete being brought over dry then mixed away from the shore and can put up hay bales and silt fencing on shoreline and the dirt is being removed from the island. The natural path was discussed.

MOTION by Mr. Turri and seconded by Mr. Koenig, it was VOTED to approve the application of Woodridge Lake Property Owners Association, 260 E. Hyerdale Drive, add 20 foot tie up moorings to the picnic area and that hay bales and silt fence be used on shoreline. Motion carries.

- B. Woodridge Lake Property Owners Association, 260 E. Hyerdale Drive - add 20 foot tie up moorings to the Dam shoreline area -** No questions.

MOTION by Mr. Turri and seconded by Mr. Koenig, it was VOTED to approve the application of 260 E. Hyerdale Drive, add 20 foot tie up moorings to the Dam shoreline area with hay bales and silt fence be used on shoreline. Motion carries.

- C. Ryan Phalen, 64 Sandy Beach Road - Build 14' diameter fire pit with patio within 75 feet of water -** Mr. Koenig asked where drainage was going and it was stated it would be a french drain with crushed stone.

MOTION by Mr. Koenig and seconded by Mr. Wadhams, it was VOTED to approve the application for 64 Sandy Beach Road, Build 14' diameter fire pit with patio within 75 feet of water. Motion carries.

5. NEW BUSINESS:

- A. Sean O'Neill, 50 Gray Lane - Removal of trees from pasture, agricultural use - Mr. Connor stated that this falls under permitted use of right for agricultural purposes 4.1.A for removal of the trees.

MOTION by Mr. Wadhams and seconded by Mr. Koenig, it was VOTED that the finding for application Sean O'Neill, 50 Gray Lane. Removal of trees from pasture, agricultural use falls under 4.1A for agricultural use as of right Motion carries.

6. INLAND WETLANDS ENFORCEMENT OFFICER REPORT: Mr. Connor stated that he may have some enforcement issues not listed yet but he is waiting on some more information and the report was discussed.

MOTION by Mr. Koenig and seconded by Mr. Turri, it was VOTED to accept the Enforcement Officer Report. Motion carries.

7. CORRESPONDENCE: None


8. OTHER BUSINESS PROPER TO COME BEFORE THE COMMISSION: None
